Child Centered Advocacy

During our training as CASAs we often hear the term "best interest advocacy" or "child centered advocacy". Our primary job as a CASA is to advocate for the best interest of the child in court. How can we make sure that is happening? Face to Face contact with the child is paramount to practicing child centered advocacy. Building a relationship (that is age and developmentally appropriate) with the child or children in your case is so important. How can you advocate for a child you do not know? You can't! By getting to know the children in your case, you are able to advocate for services they made need but aren't getting, advocate for a change of placement, advocate for increased or decreased visitation with parents, and more. As a CASA, you have a large amount of influence on different potential outcomes for children, which is a very big responsibility. Every recommendation you make in a court report, and every testimony you give in court, has the potential to influence the future of a child. These recommendations and testimony must have the best interest of the child at the forefront. Another important piece of child centered advocacy is the ability to be objective. Sometimes, what is in the best interest of a child is not always what you as a CASA would prefer to see happen in your own life, to your own children or grandchildren, etc. However, if it is in the best interest of the child you are serving, then that is what you must advocate for in both court reports and testimony. When advocating for older youth, remember to advocate WITH them and not just FOR them. Older children often have very strong opinions about what is best for them. Listen to them and take their wishes into consideration when making recommendations to the court. An adage often shared by the State of Indiana CASA Office when discussing objectivity and child centered advocacy is:

"nothing about me without them"

Remember this phrase next time you are working on recommendations for the children you serve.
